

A Note From Our Board President

2021 marks the 35th year the Rock Island Milan Education Foundation has been carrying forth our mission of "enhancing academic opportunities for student success". In the past two years, our total assets have grown over 40% due to the overwhelming support of our donors and continued market gains.

In August, students and teachers returned to their classrooms and schools committed to regaining time lost to the global pandemic and the subsequent online and blended learning. Because of your generosity, the foundation met these increased educational challenges with an even stronger show of support. In May, we awarded \$93,300 in scholarships and Austin Academic Achievement Awards to 43 seniors from the Class of 2021. Presently, 67 scholarship opportunities are available to graduating seniors pursuing postsecondary education and training. During the opening day Teacher Institute, RIMEF awarded 43 PRIME Grants to teachers, departments, schools and multi-schools, totaling \$90,214 for innovative programming and resources to encourage student engagement and increase learning opportunities.

Because of your foresight and generosity, we are able to impact the educational experience of over 6,000 students. Your investment is an investment in our future and a reflection of your belief in the value and necessity of a strong, competitive educational system for our children. As we look at preserving our natural resources, we must remember our greatest resource - our children. With increased donations comes the ability to reach more students, more teachers, and support more learning opportunities. Because of you, we will award 4 new scholarships to the Class of 2022, and for the first time the foundation will support dual credit/dual enrollment opportunities for Rock Island High School students while increasing our commitment to vocational education and the trades.

You, our donors and benefactors, are the difference-makers. Your presence is felt throughout the Rock Island-Milan school district each and every day. We hope you will continue to support our mission of enhancing academic opportunities for student success. Thank you!

Direction of Support

General Fund

Donations to our General Fund support the work of the Rock Island-Milan Education Foundation and help us make an impact throughout the Rock Island-Milan School District. All donations listed within this Annual Report were received from October 1, 2020 – September 30, 2021.

PRIME Grants

PRIME (Promoting Rock Island Milan Education) Grants provide opportunities for teachers, departments and schools to explore and purchase innovative programs or materials for their classrooms. PRIME Grants are supported, in part, by our Major Saver fundraiser, our yearly allocations for giving, and donations given directly to the PRIME Grant Fund.

Austin Academic Achievement Awards

For 41 years, the Austin Academic Achievement Awards has celebrated the academic excellence of our Rock Island High School students. At the Austin Academic Achievement Awards and Scholarship Night "Top Ten" students from each class are recognized, and the top 2 seniors in 8 academic areas are rewarded with scholarships. Generous donations from the contributors listed in this report were made for the awards given via video on May 13, 2021.

Honorarium/Memorial Contributions

Contributions to the Education Foundation are sometimes given to honor or memorialize a family member, friend, community leader, or alumnus/alumna. These contributions may be directed to a scholarship, a program, or to our general fund. These gifts are a wonderful way to remember or honor someone in your life while supporting our students and schools.

Scholarship Contributions


The Education Foundation currently administers 43 named scholarships providing up to 67 individual awards ranging from \$500 - \$5,000. From October 1, 2020 – September 30, 2021, the individuals listed made donations to establish or sustain the scholarships we award to our deserving Rock Island High School Seniors.

Accomplishments

Through an unprecedented year, the Rock Island-Milan Education Foundation supported new strategies to keep students engaged in times of both blended and remote learning. With your donations, PRIME Grants funded STEM kits that promoted thinking outside of the box and developing problem solving skills, online reading resources, and biology projects that helped students understand how disease is spread. With your donations, students at all levels in the RIMSD continued to learn. Your AAAA and scholarship gifts told our seniors that their futures matter. Perhaps the biggest accomplishment of the over \$280,000 contributed to the RIMSD was the investment you made in our childrens' education. With your generosity, the the Education Foundation:

- Awarded 69 RIMEF Named and Austin Academic Achievement Award scholarships totaling \$93,300 and recognized 95 "Top Ten" freshmen, sophomores, juniors, and seniors for the Austin Academic Achievement Awards and Scholarships presented May 13, 2021.
- Paid program fees for the INCubator.edu class at RIHS and awarded \$10,000 in prize money at the Final Pitch for 3 winning teams. INCubator total: \$15,000.
- Presented 43 PRIME Grants to 46 teachers totaling \$90,214 for innovative classroom programs and materials in the 2021-2022 school year.
- Provided HAVlife funds allowing students ages 10-15
 to participate in extra-curricular activities which they
 otherwise could not afford and for students outside of those
 age parameters, gave additional financial assistance for
 Rock Island-Milan based activities.
- Welcomed 74 new teachers, principals, and counselors with "Welcome Bags" filled with nearly \$5,000 in gift cards and supplies to help establish classrooms/offices, RIMEF information, and other treats.
- Provided over \$65,000 in additional "other" classroom assistance.


