\$73,830 Awarded to RIMSD Teachers and Schools

Rock Island-Milan School District teachers and schools were given a total of \$73,830 in PRIME (Promoting Rock Island Milan Education) Grants from the Rock Island-Milan Education Foundation at the Opening Day Ceremony for the district on August 3, 2015 at Rock Island High School.

A total of 41 grants were awarded supporting new programs and providing teaching resources to improve the quality of education for our students within District 41. All teachers and schools are given the opportunity and encouraged to apply for funding from the Education Foundation. Teachers may apply for grants up to \$1,000; school/department grants are available for up to \$3,000; and district-wide grants where multiple schools will be affected are available for \$4,000.

Each year the Education Foundation receives more funding requests than we can support. This year, grant application requests totaling over \$99,000 were submitted to the Education Foundation. The Foundation worked with the Department of Teaching & Learning in the school district to find sources for 21 additional grant requests totaling \$25,600.

The Rock Island-Milan Education Foundation was able to fund these requests through the generous donation from individuals and businesses within our community. And while we continue to work hard to increase the impact we are having in our schools, there are always unmet needs. Entrepreneurship and Enterprise Class Engages RIHS Students

Ideas are turning into action at Rock Island High School! The innovative new Entrepreneurship and Enterprise Class is engaging 50 students in an authentic entrepreneurship experience preparing them well for successful futures. In a collaborative environment, students are learning the entrepreneurship process from idea stage to execution in hopes of creating the "The Next Big Business Idea." Through a great partnership with the Quad Cities Chamber of Commerce and the Rock Island Rotary, the students are receiving coaching and mentoring by real entrepreneurs and business experts under the guidance of RIHS classroom teachers.

Here's what the students have to say about the Entrepreneurship Class:

"Outside the walls of the traditional classroom, entrepreneurship is an innovative approach to learning. Throughout these first few months, we have been exposed to real world applications and seen a different approach to learning. As we develop as entrepreneurs, we master and understand many concepts as well as using technology to our advantage as an essential part to this course.

Social interactions are an essential piece to entrepreneurship. On two occasions, we got to experience the importance of growing our social skills in the business world. August nineteenth the entrepreneurship program had the fortunate opportunity of seeing Daymond John and hearing his philosophy to entrepreneurship. Secondly, on September twenty-second a special luncheon was held by the Women's Connection to increase financial literacy and education amongst members through LearnVest.com. We hope to encounter and learn from many more of these opportunities as the year continues.

Additionally, the learning environment that has been created for us helps us to flourish academically. With the guidance of expert coaches and mentors we learn at the highest level. Each day, and the help of Macbooks and station monitors, collaboration is possible. Group members can effectively work within the fifty minute time frame we are constrained with. Through Google Documents, we can create customer segments to narrow our client base, review our competition, and compose letters to potential partners. Canvas (headquarters for lesson plans and assignments) assists us to focus more of the joy and concept of learning rather than solely getting a decent grade.

By entrepreneurship and collaborative environment, we are presented with a different style of learning that expands our horizons, breaks down educational barriers for the better, is creating enhanced versions of ourselves."
